- 1) Minutes from previous committee meeting agreed.
- 2) Matters arising from minutes of previous committee meeting
- a) The committee decided to adopt a more concise and simpler minutes writing method.
- b) David had circulated as requested a copy of the normal timescales for the annual renewal process.
- c) David provided an update on the agreement to add additional new members from the waiting list up to a maximum of the Bacon capacity of 566.
- d) Chris will inform the committee of details of the success of the Musicals! Event.
- 3) **Adoption of Operating Principles** John suggested some necessary edits which the committee agreed and following Michael updating the Operating Principles John will then include these on our website.
- 4) *Update to Financial Principles* these were agreed and David will forward a copy for John to add to our website.
- 5) *Financial Update* these were noted although there was a recommendation that we investigate our present webhosting agreement/costs.
- 6) *CFS Extra Proposals for 2020/21 season* there was a general discussion concerning the present suggestions for our next CFS Extra with the committee deciding that we should also consider alternative ideas. Consequently, a team consisting of Andrew H, John, Pam and Stephen llott will consider and suggest further ideas/themes and films for our next CFS Extra. Michael suggested that this team should report back to the committee late March time. We agreed to go ahead for the next season with the usual number of films: i.e., three.
- 7) Proposals for Innovation Projects
- a) Chris introduced his Science Fiction films idea for a possible innovation event to coincide with the next Cheltenham Science Festival. Michael commented that this needed further

investigation and cost analysis before we might proceed with this idea, and we could also look at film tie-ins for all the festivals, not this year necessarily but over the next few years. John also mentioned that a further possibility could be a film event to coincide with the next Cheltenham Classical Music Festival? John offered to contact Paul Scott at the Playhouse regarding further film innovation ideas.

- b) Michael will investigate the purchase and training involved in acquiring a de-fibrillator unit.
- c) John has offered to investigate the cost and possible purchase of our own film projection kit.
